By-law Revamp Discussion result: Since it is most imperative that other issues are addressed before we can revamp our bylaws, it was tabled for a future time.

DSR

It was suggested that we book a meeting room an Cinzetti's at I-25 and 104th for this purpose as well as to check Cinzetti's out for a possible northern club meeting place for revolving monthly club meetings.

Central Storage for Important Club Information

From this point, the recording secretary will number club motions by year, month and sequential numbering.

Objectives (Requirements) for Central Storage

It should have ease of adding and subtracting members to the website. Each person has individual passwords to get into this, so one main password cannot be shared.

All members will have access to past club motions on the Google Drive. The Newsletter is the club's transparency. There should be a Communication Committee.

Newsletter

The secretary will send the minutes for the President's approval and thepresident will sent this and the newsletter out by email (Martha Lageschulte agrees to do the Newsletter and this will be created with Adobe In Design software)

MOTION 22-1-001: Terry Walb moves that JoDee Putnins set up a temporary Google Drive to be attached to the DSA Website for the Board and Officers to store confidential Club business.

Discussion: We can lock the files as Read Only so club information cannot be changed. Terry: "No matter what we do with the website, it will take time, will the Goggle Drive solve the problem of storage?"

Membership Survey

Treasurer's Report

Actual figures for the Treasurer's Report are found on separate sheets at the end of these minutes.

Discussion: Because we had no local specialty shows in 2020, and no agility trial in 2021, our year end report does not show a profit.

Last year we were in the red for the local specialties by \$2746.00 (for ribbons and trophies), however, these were used in 2021, and our profit in 2021 was \$650.00 for the specialties.

We had a large output for Erica Flahaut's expenses of \$1300.00.

We had no agility trial in 2021 to offset these costs.

T-shirt sales help us to offset our costs, and should continue.

DSA Budget

Should we keep our target budget at \$20,000.00?

Spending needs to be based on what we take in.

Question: Might \$12-\$15,000.00 be enough?

Denver Samoyed Rescue Budget is significantly higher than DSA's. Money is needed in reserve to take care of health issues of rescue dogs. We have foster homes, but no agreement with a shelter

Shelters have better luck rehoming dogs We also may need to be able to donate to other rescues when they have a large influx.

King Soopers Grocery Program brought in \$2000.00 and can support some of our events, such as the Christmas Party.

We should reach out to our puppy buyers to sign up for the King Soopers program.

Scooter will checkout Amazon Smile to see if we qualify for a percentage of our members' purchases to be donated back to DSA

Club Donations: should these be conformed to a certain amount?

The Board should review our donations of DSA with regards to our memorial giving to SCARF and trophy donations to the SCA National Specialty each year.

If there are no memorials during a given year, then money is to be donated to SCARF in memory of members' dogs lost during that year:

- SCARF \$500.00 for loss of each member
- SCARF \$200 one smaller donation given in memory of members' dogs lost

• SCA — trophy donation of up to \$300.00 (lately we have given \$100.00) to the annual National Specialty.

MOTION 22-1-002: Julie Morris moves that in 2022 DSA donates \$150.00 to the SCA National Specialty.

2nd: Heidi Nieman

The motion was unanimously approved.

Discussion of who might receive our donation money for memorials:

It was thought that we might consider not donating exclusively to SCARF since other canine health entities are doing important work we should support SCARF has not accomplished a lot in recent years.

Health Organizations such as FLINT for canine cancer research at CSU and research grants by the Morris Animal Foundation are some other choices.

MOTION 1-22-003: Linda Kitzman moves that DSA donations be given to the Canine Health Organization of DSA Club members' choosing in the amount of \$300.00 for each deceased member's passing.

2nd: Martha Lageschulte

Discussion: This motion TABLED until the January Club meeting

Judging Contracts

We will review the judging contracts of other dog clubs to see what they offer in an attempt to possibly revamp our own contract for our local specialties and agility trial. There were offers to try to obtain the judging contracts of at least the Australian Shepherd and Golden Retriever clubs.

Other club members should be considered for some of these chairmanships. Pam also will reach out to committee chairs for each of their budget requirements

President's Report

Pam Buhl went over the January Board Meeting. The DSA Board/DSR meeting was announced for February 6 at Cinzetti's at 12:30 p.m.

Central storage in the G-Drive was discussed as a stop gap measure until a new website can be created.

Discussions: Google Drive, a Communication Committee to oversee this and the creation of the website as well as administration of it.

Also discussed was: using What'sApp for club membership for quick announcements, Email to the membership, or IO Groups — all possibilities to announce meetings, etc.

We cannot make any decisions until all of our dues have come in

We will discuss the AKC/PAC (Political Action Committee) donation for "Purebred Dogs Under Attack" with the club membership at the February meeting.

Local Specialty

\$200.00 was anonymously donated for New Title ribbons at our specialties. Should we continue this? The discussion trended towards letting this ribbon category go, and it should not go into the local specialites' premium lists unless the donator wants this to be continued.

Karen Brook-Hodges has donated \$100.00 to this year's trophy fund.

The meeting was informally adjourned at 8:44 p.m.

DSA/DSR BOARD MEETING February 6, 2022, Cinzetti's Italian Market, Northglenn, CO

Meeting called to order 12:45 pm. Present: Julie Morris, Jan Cherne, Martha Lageschulte, Terry Walb, Heidi (Scooter) Nieman, Pam Buhl, Lori Elvera, Linda Kitzman, Donna Dannen, Sue Wangerin, Michele Sotille

The meeting was held to solidify the future of the Denver Samoyed Rescue, and to fix priorities for this element of the Denver Samoyed Association.

Rescue Report

Sue Wangerin has sent in our \$325.00 renewal to PACFA. It was discussed that our current level of activity is so low for rescues, do we need to stay with PACFA? Sue made it clear that we must do this as part of Colorado Law.

Currently our only activity is to do referrals to other groups Sue checks email for any actions needed to be taken, Michele checks the PO box for any mail

DSR needs to have the website up and running for DSR advertising purposes. It was reported that Network Solutions needs to unlock the website. We need to decide who might help create a new website once the password is unlocked.

There was a question concerning the need for an agreement with some boarding facility should it be needed in the future. We do not have this as part of the current plan because our needs are not consistent.

DSR fiscal assets are quite large, the money might stay for emergency purposes since medical bills for rescues are expensive and can quickly use up what is on hand. Or the money might be allocated to other rescue groups if ours was to dissolve.

Sue and Michele said they are committed to continue our rescue services, plus continue with the group's sales as a way to keep the fiscal reserves high.

Without the website to sell the collar/leashes and hiking systems for DSR, the DSR Facebook page might be a stop-gap. It was discussed about how to make that work. Michele and Sue will need to learn the ins & outs of Facebook.

DSR will make a simple end-of-month report to the president of DSA on how much inventory was sold each month.

A communications committee will be formed by DSA for work on the future website that will include DSR. A member of DSR should be on that committee.

Other Business

Discussion on storage of DSA items used for events - Jan Cherne presented a several storage unit suggestions, with the cost for each.

Alternatives: Pam's attic; Linda Kitzman's storage unit; members storing various items.

Pam asked that we all take inventory of club items we are storing, with pictures, by 2-13-22, and email them to her.

Terry Walb has been searching to find a more central meeting place for DSA. Each place she has found has included a fee or requirement to use their facilities.

Our next meeting will be held at Julie Morris' home, in her barn. Please bring your own chair to the meeting.
