# CSU's Small Animal Vaccination Protocol

In the past there have been many different vaccination recommendations for dogs and cats from veterinarians across the United States based on the best available information. In light of new information, the Colorado State University Veterinary Teaching Hospital is offering its clients the following vaccination program. This program is designed as the routine immunization program for Colorado State University's clients' dogs and cats living in Larimer County, Colorado, USA in conjunction with a complete physical examination and health evaluation. This program is modified for any patient with specific risk factors.

Not all available small animal vaccines may be suitable for our program. Infectious disease risk may vary and our routine vaccination program

may not be suitable for all localities. Anyone using our routine vaccination program is encouraged to follow the guidelines that are its basis and use the program at their own risk.

For pet owners, your local veterinarian is your best resource to develop a vaccination program tailored for your pet. The health status and infectious disease risks of your pet should be considered in the selection of a vaccination program.

Our adoption of this routine vaccination program is based on the lack of scientific evidence to support the current practice of annual vaccination and increasing documentation showing that overvaccinating has been associated with harmful side effects. Of particular note in this regard has been the association of auto-

immune hemolytic anemia with vaccination in dogs and vaccine-associated sarcomas in cats -- both of which are often fatal. With boosters (except for rabies vaccine), the annual revaccination recommendation on the vaccine label is just that -- a recom-

mendation without the backing of long term duration of immunity studies, and is not a legal requirement. Rabies vaccine is the only commonly used vaccine that requires that duration of immunity

studies be carried out before licensure in the United States. Even with rabies vaccines, the label may be misleading in that a three year duration of immunity product may also be labeled and sold as a one year duration of immunity product.

Based on the concern that annual vaccination of small animals for many, but not all, infectious agents is probably no longer scientifically justified, and our desire to avoid vaccine-associated adverse events, we are recommending the described routine immunization program to our small animal clients.

This Program recommends the standard three shot series for puppies (parvovirus. adenovirus 2, parainfluenza, distemper) and kittens (panleukopenia, rhinotracheitis, calicivirus) to include rabies after 8 weeks of age for cats (Canary Pox Rabies only) and 16 weeks of age for dogs. Following the initial puppy and kitten immunization series, cats and dogs will be boostered one year later and then every three years thereafter for all the above diseases except for rabies in cats which receive the new safer canary pox rabies vaccine that requires annual boosters. Similar small animal vaccination programs have been recently adopted by other university teaching hospitals and the American Association of Feline Practitioners.

Other available small animal vaccines, which may need more frequent administration, i.e., intranasal parainfluenza, Bordetella, feline leukemia, Lyme, etc., may be recommended for CSU client ani-

mals on an "at risk" basis but are not a part of the routine Colorado State University protocol for small animals. Recent studies clearly indicate that not all vaccines perform equally and some vaccine products may not be suitable for such a program.

#### Feline Leukemia Vaccine

To be used **ONLY IN HIGH RISK** cats. Best protection: Two vaccines prior to 12 weeks of age, since younger cats are most susceptible to FeLV. One booster at one year of age.

### **Healthiest Pet Cities**

(NAPSI)-A new study reveals which U.S. cities are top dogs when it comes to pet health.

The study, conducted by the Purina Pet Institute, ranked those cities that exemplify superior care, services and legislation for pets' health and well-being. It analyzed 30 different criteria ranging from veterinarian-to-pet ratios to incidence of obesity to rabies legislation. The top five Pet Healthiest Cities are:

- 1. Denver, Colo.
- 2. Oakland, Calif.
- 3. Portland, Ore.
- 4. Anaheim, Calif.
- 5. San Francisco, Calif.

"This is the only comprehensive evaluation of factors that impact pets' health and affect their quality of life," said Dan Christian, DVM, executive director of the Purina Pet Institute.

The data revealed that pet obesity/body condition and preventative care are major issues. According to veterinarians surveyed, more than half of the nation's cats and dogs are overfed, which can lead to health problems. An unprecedented 14-year Purina study proved that feeding dogs properly throughout their lifetime to maintain ideal body condition can significantly extend their healthy years.

#### Other significant results:

- Cats and dogs in San Francisco can claim clean lungs—the city has the lowest cigarette usage in the report and boasts zero annual ozone alert days.
- New York City and Oakland scored highest for percentage of dogs neutered (83 percent) and New York City tied with San Jose for highest percentage of cats neutered (86 percent).
- In the body condition category, New Orleans scored highest for percentage of dogs at ideal body weight (50 percent) and Nashville took top score for percentage of cats at ideal body weight (50 percent).
- Columbus, Ohio leads the country in the veterinarian-to-pet ratio with one veterinarian for every 745 pets.

While it is important to understand the environmental elements that affect a pet's health--such as the availability of qualified care, the prevalence of fleas or the requirements of licensing-there are

many things individual pet owners can do to help improve their pet's health.

"The things pet owners control -obesity, preventative care, spaying and neutering—can literally add, or detract, healthy years from a pet's life," said Christian.

PETS LOVE: Denver received the highest score for emergency and critical care with 62 veterinarians accredited by the Veterinary Emergency and Critical Care Society — more per capita than any other city in the report. In addition, Denver also scored extremely well in the area of preventative care. According to the national veterinary survey, Denver dogs and cats took top marks for being spayed/neutered and for being at their ideal body weight. The city also stands out from the pack with five animal shelters per capita approved by the Society of Animal Welfare Administrators, a not-for-profit management organization of professional administrators whose goal is to provide members with superior opportunities for training and information exchange. The Mile-High City's air quality is excellent, with only three ozone alert days per year. Denver boasts one of the lowest flea populations of any city in the report and the watershed quality rates very high, important as drinking water serves as the primary source of hydration for pets. Additionally, incidences of Lyme disease are low compared to other metropolitan areas, and cats and dogs are well protected under strong rabies and license legislation — all pets must have an ID tag and a rabies shot certification is required before licensing. Per capita, Denver has the third highest veterinarian-to-pet ratio, with one veterinarian for every 782 pets.

# **Voting Process for DSA Specialty Judges**

# DSA's process for voting for Specialty judges is derived from Robert's Rules of Order.

Nominations are taken at one meeting. Names are submitted for puppy sweeps, working sweeps, obedience, and regular conformation classes. The regular conformation-class judge alternates each year between an All-Breed judge (odd-numbered Specialty year) and a Samoyed-Breeder judge (even-numbered Specialty year). The nominated judges are then listed in the Sam-O-Gram for the membership to review prior to the next meeting where the voting occurs.

At the next meeting the names within each category are drawn randomly and are listed in that order on a board. Each name is voted on in that

order until a majority YES vote is reached. Every member is allowed to vote yes or no for each judge. In the example below, there are 10 voting members present, so a majority requires at least 6 yes votes if nobody abstains. If anyone abstains, then the total of the voters is reduced and a smaller number is required to reach a majority.

For example: There are 10 DSA members present (DSA-1 through DSA-10). There are 4 judges whose names have been submitted. They are Judge-1 through Judge-4. When pulled randomly, they now fall into the following order: Judge-3, Judge-1, Judge-4, and Judge-2.

#### The following is a demonstration of voting:


