It's unusual for a trial early in the new year to fill so quickly. Bev Brinson is the new trial secretary who replaced Helen Hittesdorf.

#### **DSA Specialty 2025: JoDee Putnins**

Pam Arnold verified that Christie Martinez will attend DSA 2025!

Terry Walb shared information from Dougco about upcoming changes. We'll be working for a new person, but it's unknown who. RV rates will increase for '26.

Terry forwarded the Dougco email to the board. Small clubs will not be able to schedule more than 6 months out. It's possible you could get more time if you need to get approval from parent club. DSA typically reserves a year ahead.

Fire Department reviewed our plans for the rings and layout at the specialty. Our contract with Dougco requires a schematic of rings.

#### **Concurrent Specialty June 2026: Linda Kitzman**

Linda Kitzman reported on the concurrent specialty planning. Andrea Floyd of Flatirons Kennel Club was notified that we want the pavilion area on Saturday in the morning and that the specialty will be concurrent. There is an FKC planning meeting this coming Wednesday.

Judges: we do not have a judge's liaison for the June 2026 show, which complicates DSA choice of judges. Linda Kitzman suggested that since Martha Lageschulte is already on the judging panel for FKC, and is judging other breeds, she could judge our concurrent specialty.

Any dogs that a judge co-owns cannot be shown at any shows that weekend. Dogs that are not co-owned by a judge that is on the panel, but not judging that breed, can be shown; i.e. the Martin's can show dogs that Martha does not co-own at the concurrent and other shows.

We discussed whether the Board could make the decision about the specialty judge, or should we include the members.

- Who is on the FKC judging panel and is qualified to judge Samoyeds
- When is our deadline to tell FKC our judge choice
- We want membership input, but time is short
- As soon as possible we will list the judges on the FKC panel on WhatsApp and ask for judge preferences.

- DSA board will hold an emergency meeting to make the final decision



Photographer, nature and outdoor writer, seminary graduate, Samoyed lover, Kent Dannen was an extremely varied and complex person. He wrote extensively about the natural world, our place in it, and the stewardship that it requires. He was heavily influenced by the writings of John Muir, the famous conservationist who campaigned for the creation of Yosemite National Park. Muir looked at the natural world as God's creation for which humans have responsibility. Kent wrote as often about dogs as he did about the natural world. Several of his books were about the care and responsibility of pet ownership. Newspaper and magazine articles were often about the question of "Do Dogs Go to Heaven?" Kent believed that they do. He also co-authored Rocky Mountain National Park hiking guide books, Colorado wildflower guides, and Reader's Digest travel books to places of natural beauty. Kent's writing and photography appeared in well known publications such as Audubon, Nature, National Wildlife, National Geographic Traveler and the American Kennel Club Gazette. He is remembered in the dog world for the calendars he photographed of several dog breeds, especially Samoyeds. Kent participated in the creation of the Samoyed Club of America's Working Samoyed program, and wrote extensively about the bond created when one works with his or her animals. This bond was most important to Kent as he trained and showed his favorite breed until his passing in 2024.

#### A Step Ahead: How Genetics May Help Prevent Cruciate Ligament Rupture in Dogs

#### A Familiar Injury with Surprising Roots

If you are a sports fan, or one of the thousands of people who will tear an ACL in your lifetime, you understand how devastating a knee injury can be. A single wrong step can lead to painful surgery, costly treatment, and a long road to recovery.

#### Dogs face the same risk.

Just like humans, dogs rely on a complex system of ligaments to stabilize the knee. One of the most important is the cranial cruciate ligament, or CCL, which serves a similar function as the anterior cruciate ligament (ACL) in people. When this ligament ruptures, the result is pain, instability, and limited mobility.

Certain breeds, such as Labrador Retrievers, Rottweilers, and Newfoundlands, are especially prone to this condition. Others, like Greyhounds, rarely experience it. This difference raises an important question. Is the cause purely physical, or does a dog's genetic makeup play a role?

#### From Inheritance to Injury

Dr. Peter Muir, a researcher at the University of Wisconsin–Madison, has spent years investigating this issue with funding from the AKC Canine Health Foundation. His research confirms what many suspected. Cruciate ligament rupture is not simply an injury. In many dogs, it is a heritable disease.

"The first question we needed to answer was whether this is an injury or a disease," Dr. Muir explained. "Historically, it was considered an injury. But the evidence increasingly shows it is a disease with genetic roots."

That finding changed the landscape of treatment. If the condition is heritable, then it may be predictable. And if it is predictable, it may also be preventable.

#### A Tool for Targeted Prevention

Dr. Muir and his team set out to take the next step. Could they create a genetic risk test that would predict a dog's likelihood of developing cruciate ligament rupture?

In Labrador Retrievers, the answer is yes.

By studying data from more than one thousand Labradors, the team developed a polygenic risk test for the breed. This test analyzes thousands of genetic markers to estimate a dog's risk of developing cruciate ligament rupture. The success of this test represents a major advance in veterinary care and could pave the way for personalized prevention.

Dr. Muir is now working to develop similar tools for other high-risk breeds, including Rottweilers and Newfoundlands. One of the challenges is recruiting a large enough sample size to map the breedspecific genome effectively.

#### Why It Matters

Cruciate ligament rupture is not typically fatal, but it can be life-altering. It often leads to expensive surgery, months of rehabilitation, and reduced quality of life. In severe cases, dogs may never fully recover.

Dr. Muir believes that widespread use of genetic screening could transform how veterinarians manage orthopedic risks. If high-risk dogs are identified early, they can be monitored more closely and treated with greater care.

The Labrador Retriever polygenic risk test is currently available through the University of Wisconsin–Madison. While early adoption has been slow, Dr. Muir is optimistic about the future.

"Cruciate rupture can disable a dog for a long time," he said. "Even for the average owner, most would agree they would rather have a dog that never experienced it."
