I hope this email finds you all well. I just want to update everyone on the new DSA breeder referral listing on our webpage. If you were present at our January and February meetings, you know we are working to update the breeder referral section of our webpage. It will now include a volunteer listing of members who are breeders, or are willing to provide education and information to people seeking a Samoyed. In the last year especially, the task of answering the volume of emails sent to both breeder referral and rescue increased to the point that it became almost overwhelming. The board developed the idea of this listing in response to the increase in interest in the Samoyed breed.

Our breeder listing will be modeled after the SCA breeder listing. Attached you will find a form to com-

plete to be listed on the

website. This is totally voluntary, but if you would like to be included on the DSA breeder listing, simply complete the form and email back to the Treasurer (Thalia). If you want to be listed as a person with expertise in a certain dog sport, just indicate that on the form. In the future (2022 and beyond) this form will be sent out with the dues renewal packet every year, and you will need to return it each year if you want to be listed so that the information is up to date.

If you are listed on the website, you will likely receive many emails from people looking for information and puppies. Please remember that by being listed on the DSA website as a member breeder, you represent not just yourself and your breeding program, but the Denver Samoyed Association also. Be courteous and kind in your responses, and take the time to educate the person about our wonderful breed when possible. If you have no plans to breed, please refer people back to the listing. As Breeder Referral Chairperson I am always happy to answer questions, so you can refer people to me via email.

The Board feels strongly that this new format will allow the Denver Samoyed Association to fulfill its mission of educating the public about our breed in a more efficient and more effective manner, and also help our breeder members be connected with people seeking information on the breed and available puppies. Much thought and time went into developing this idea and the form. Many thanks to Thalia for patiently incorporating all the changes to the form as the Board worked through this process!
