What is a Puppy Mill?

Below is an article by Charlotte Clem McGowan. Charlotte is a noted breeder/judge, the AKC Legislative Liaison for the American Shetland Sheepdog Association and was given an award by AKC a couple of years ago for her legislative work.

I cringe now when I hear the phrase "puppy mill."

What I have to say may not win any popularity contests for me but it needs to be said.

- What is a puppy mill? You have your definition I am sure. But there is no LEGAL definition of a puppy mill. Because we in the fancy have freely thrown this phrase around, we have actually aided the animal rights activists. As far as the animal rights activists are concerned, a puppy mill is anyone who purposefully breeds ANY dogs, even a single litter! I will bet you do not agree with this definition. But take a look at Calif. AB 1634 and see what's going on. In terms of AB 1634, you breed a litter, you're a PROBLEM! That's the way that bill is framed.
- If there is no legal definition of a puppy mill, should we be in favor of preventing all breeding of dogs based on our own personal definition of a "puppy mill?" I think not. People want pets. You and I don't breed enough to supply them. Think about that!
- Can we agree there is a definition of a puppy mill? I think not. Ask 10 fanciers independently and you will get 10 different answers. So what does the public think? How does the public (not dog breeders) define a puppy mill? Here is

where the AR's have used us. They talk about "overpopulation" and the need to stop ALL breeding. We talk about "puppymills" and stopping puppy mills. So the public is now confused since there is no legal definition of a puppy mill. The public is beginning to view breeders, all breeders, as puppy mills. We have contributed to public perception. We don't breed enough to supply the public's desire for pets but we oppose breeding by others who see a need and plan to fill it for profit.

- We need to stop buying into the "overpopulation" rhetoric. People want pets and people will have pets. It is a matter of who will supply those pets. We need to focus the public on the value of purebreds over the various doddles and poos and mutts imported from Mexico, Puerto Rico and everywhere else. As long as we talk about "puppy mills" we are missing the boat. Talk about substandard kennels if you like. Talk about conditions. No one approves of dogs badly kept. Talk about diseases brought in by mutts from tropical climates. But don't talk about puppy mills.
- Petland and Hunte exist for a reason: people want pets. They are commercial entities. We hobbyists don't like the idea of commercial entities. That's been clear for ever so long. Does that mean that all commercial sellers are "puppy mills?" Well, there is no legal definition, please remember. Petland and Hunte probably do a

Put Your Car Keys Beside Your Bed at Night

Tell your spouse, your children, other members of your family, your neighbors, your business associates, your clients, your Doctor's office, everyone you run across.

Put your car keys beside your bed at night. If you hear a noise outside your home or someone trying to get in your house, just press the panic button for your car. The alarm will be set off, and the horn will continue to sound until either you turn it off or the car battery dies.

This tip came from a neighborhood watch coordinator. Next time you come home for the night and you start to put your keys away, think of this:

It's a security alarm system that you probably already have and requires no installation. Test it. It will go off from most everywhere inside your house and will keep honking until your battery runs down or until you reset it with the button on the key fob chain. It works if you park in your driveway or garage If your car alarm goes off when someone is trying to break into

your house, odds are the burglar he won't stick around... After a few seconds all the neighbors will be looking out their windows to see who is out there and sure enough the perpatrator won't want that.

And remember to carry your keys while walking to your car in a parking lot. The alarm can work the same way there This is something that should really be shared with everyone. Maybe it could save a life or a sexual abuse crime, or help you in some other personal emergency. I hope this has been helpful.

Got 'Shrooms? Hope Not for Your Dog's Health Sake!

CONIFER - One dog lover has a warning for others: The mushrooms growing because of all the moisture can be deadly.

Jeff Clark's property is green and lush because of all the rain in the last six weeks.

"I have never seen another year like this. It has rained almost every day up here," Clark said. In all the tall grasses and thriving flowers and bushes in his yard are hundreds of mushrooms.

"There are dozens of different kinds of them. They are popping up all over the place. It is crazy," Clark said.

His dachshunds, Zoe and Daisy, love to hunt for field mice. Herman, the family's third dog, used to love to explore the yard too.

"He just like to get into things too," Clark said.

"He liked the backyard. He liked running in the backyard, so that is probably where he found the mushrooms."

Jeff Clark says those mushrooms are what killed his 2-year-old dog.

"The dogs just seem to like them," he said.

"They are flavorful but they are deadly."

Clark said on Saturday evening he noticed Herman was salivating a lot. The dog threw up his dinner and seemed lethargic. A few hours later he seemed to be feeling better and fell asleep. The Clark's say when they checked on Herman at 4 a.m. he was dead.

"It broke our heart. It has been a very tough couple of days," he said.

At the Conifer Veterinary Hospital, the staff is seeing a lot of cases of possible mushroom poisoning; more than they've seen in past years

Dr. Jason Johnson said: "We are seeing a couple of cases a week of suspected mush-room intoxication in dogs and most of those are pretty sick pups."

Marilyn Shaw is a mushroom expert. She says there are dozens of kinds of mushrooms growing right now. There are more mushrooms than in a typical year because of the all the rainfall. Most mushrooms are not harmful. She says two types in particular are toxic to dogs. One is

bright red with white spots; the other is a lighter tan color.

"If they eat them, symptoms that start about 30 minutes to two hours after the mushroom is eaten include: the dog starts staggering like it's drunk, it can finally collapse, muscle spasms, twitching," Shaw said. "The dog can even slip into a deep coma-like state."

Johnson said: "Most of the time, with quick intervention and supportive care, the dogs can recover. The smaller the dog is, the greater the risk that they won't."

Jeff Clark said: "When you are out hiking up here in Conifer or Evergreen, keep them on the leash and keep your eye out for mushrooms. If your dog takes off into the bushes, they can find them fast and munch down a bunch of them pretty quick."

He said he wanted to share Herman's loss to warn others of what can happen.

"I just want to get the word out because we are all animal lovers here in Colorado," Clark said. "I don't want anyone else to go through what we have."

much better job of selling commercial bred dogs than the mass breeders of doodles and poos and the chances of a Petland dog being healthy are way ahead of what the chances are for the mutt imported from Mexico or Puerto Rico. But the animal rights activists have been extremely successful in convincing you, the hobbyist, that all commercial bred dogs are bred in filth and squalor. In fact, that's not true. The terrible kennels of the 80's have in large part been weeded out by AKC's Inspections and Investigations department and 5000 inspections a year along with the USDA inspections. There are still some bad kennels, but guess what, there are bad hobby breeder kennels! Does that mean because you may personally know

- of a kennel where the dogs are not kept well, that all hobbyists are bad? Of course not. We just don't like the idea of commercially bred pets. But definitions count!
- 6. Historical fact: Some of our founding breeders of our own Shelties, people we all respect, made a lot of their living selling dogs including pets. People like Dot Foster (Timberidge) chief author of the current standard, Betty Whelen, excellent and beloved breeder, etc. There was a time it was ok to breed lots of dogs and sell the non showdogs for pets, and do it proudly. What happened? We all convinced ourselves we shouldn't breed too many dogs. We left the door open for commercial breeders and sellers.
- The animal rights people have changed the landscape. If you help protest "puppy

mills" please remember there is no legal definition. Some of the commercial breeders have state of the art kennels. I know you don't want to hear that, but it is true. Does a commercial kennel that is state of the art qualify as a "puppy mill?" Does your fellow breeder who breeds two extra litters of puppies a year qualify as a puppy mill? Does your single litter quality you as a puppy mill? Depends on whose definition you use. And remember that as we fight bad legislation, we are ALL Puppy Mills according to the animal rights activists!

Let's concentrate on the real enemy: the animal rights activists who want no purposefully bred dogs at all.


This is a very good problem to have for Sammy Rescue!

However, since the report is published monthly, it does not reflect the fact we have had adoptions that occurred between newsletter publications.


So far this year, we have had five adoptions that have occurred this year.

New Working Sweepstakes Rules

The Working Sweepstakes is open to all Samoyeds that have accumulated 100 points during the year toward their WS title or that have received a qualifying score towards an AKC title for the Pre-Titled class; or have obtained an SCA Working title or other AKC performance title

Dogs may be neutered and bitches may be spayed. Samoyeds may be registered with an ILP/PAL number. Samoyeds in the Working Sweepstakes need not be entered in another class at the show.

Proof of eligibility must be submitted to the DSA Show Chairman prior to the closing of entries. Pre-titled entrants must submit either: (a) an SCA tally sheet showing 100 points accrued in any of the categories contained in the SCA Working Title Program, or (b) a copy of the qualifying ribbon from an AKC performance class. Either of these requirements must have been met during the 12-month period prior to the closing of entries. A copy of the SCA Working Program certificate or AKC Performance Title certificate is required for titled entrants. Electronic mail or Fax is acceptable.


