Meeting called to order 10:10 am

#### **DSA 2024 Specialty Wrap Up**

We owed Douglas County Fairgrounds \$31 for per entry fees for 2024 regular classes (96 dogs).

Pam compared net proceeds in 2023 and 2024 in document below. 2024 income was lower: entries were down, but also t-shirt income was much lower. We had to pay \$327 for t-shirt mistake.

Income was reduced by \$84 for entries using worker coupons, \$120 for banquet.

Judges gift came from trophies line item.

Cheryl did not submit decorations paid by her. We need those expenses to be visible, and to know value. Martins' payment of those expenses can be shown as a donation to the club.

New title ribbons are now shown as an expense. In the past, Cheryl McCloud donated new title ribbons, but we ran out, and stopped providing. Terry purchased 10 ribbons costing \$184. New title ribbons need to be in premium list so can be awarded in the ring and communicated to stewards. They can be generic—no theme. If desired, exhibitor can return to DSA after photo.

**MOTION 25-001B**: Beginning in 2025 DSA to provide new title ribbons at local specialty. Terry Walb move, Rodney Martin 2nd. Passed unanimously.

We received thank yous from judges Cheri Hollenback and Lia Benson. Cheri didn't charge all fees—e.g., only half of airfare. Obedience judge cost was \$301.

#### **DSA 2025 Specialty: JoDee Putnins**

Specialty theme ideas:

- Fairytales
- Alice in Wonderland
- Castles and Dragons.

Martha Lageschulte—logo could work for either one. Castles—similar to last year, dark, not focused enough

We chose Alice—"Sammies in Wonderland".

If we have the logo completed soon enough, we can get trophy stools from Heart of America Specialty.

Assistant Chair—Terry Walb, Ribbons—Lori Elvera; Trophies- Julie Morris and Jan Cherne.

Tip for trophy chair—earlier, longer close date

allows later trophy purchases.

Hospitality cost increases—wraps are no longer available at Costco. Quantities were adequate. Chocolate difficult to store.

Trophy Donations— Offer trophy donation to those who won previous year first before offering public trophy donations.

At the specialty: next year trophy sheet available early—as soon as the win on Saturday.

#### Steward's Pay

Obedience, rally: not as long, but more complex. Stewards show up early, reset ring.

Conformation: longer days.

DSA stewards have gotten gifts like t-shirts, bags, etc.

No other gifts. Lunch is provided.

**MOTION 25-002B**: Starting in 2025 and going forward obedience/rally stewards will be paid \$30 per person; conformation stewards will be paid \$30 per day or \$75 for entire weekend in lieu of aifts.

Pam Buhl move, Julie Morris 2nd. Passed unanimously.

#### **Sweepstakes Judges Compensation**

A few clubs provide hotel room for sweepstakes judges. We discussed offering a voucher towards room. Rules preclude paying sweepstakes judges. We will hold off on vouchers and stay with gifts.

Entry Fee Increase:

- Current entry fees for DSA-\$25 sweeps-\$28 regular classes; in 2024 we raised slightly because of AKC fee increase.
- Other clubs' entry fees: \$32-34. Additional dog: \$5-10.
- Sweepstakes fees are not an issue because fees go back to winners.

**MOTION 25-003B**: Starting in 2025, entry fees will be \$30 for the first entry and \$25 for additional entries on the same day and for sweepstakes. Junior showmanship will still be free.

Motion Linda Kitzman, Donna Dannen 2nd. Passed unanimously.

We discussed whether to add a Brace Class on Sunday or both days.

Considerations—would require additional ribbons and trophies.

**MOTION 25-004B**: Beginning in 2025, DSA will offer brace class on Sunday.

Linda Kitzman move, 2nd Julie Morris. Passed unanimously.

We discussed having Juniors both days. Not all judges can do juniors. Could bring judge in for second day. JoDee will ask Marlene Groves about costs for a second day of juniors. We will table discussion until the March meeting.

Donna Dannen will be responsible for judges' gifts.

Pam Buhl will consolidate existing gifts and trophies at her house.

The show closing date will revert to closing entries a week earlier: Lorraine needs to know we close earlier.

Fees charged by Lorraine and Ginger were less than expected.

For 2025 specialty, Lorraine will prepare sweepstakes prizes and will send envelopes with stickers, and we just put money in envelopes.

Music: Jim Cheskawich's has supplied the sound equipment in the past. Lori Elvera bought speakers and a microphone, so Jim won't have to lug heavy equipment to the specialty. We still want him to do the playlist for us!

#### **Show Photographer**

Exhibitor participation is important to help with photos.

We need to ensure we have one photo of every win.

Need wrangler to get dog's attention and for throwing toys in a timely way.

We discussed our photographer options: FastCAT-Tales of Voyage may not charge but asks for recognition. JoDee Putnins suggested contacting Riley Cox photography. Formal show photography is a specific skill set.

Donna Dannen will contact photographers and oversee. Donna D. and Lorrie McAllister will develop a punch list for the photographer.

Pam Arnold will not do judges' liaison beyond 2026. Linda Kitzman will discuss the job with Pam.

Martha Lageschulte asked JoDee Putnins to attend the next board meeting to report back on Specialty.

Traditionally the show chair appears in photos. JoDee is not able to do this. DSA will designate alternates ahead of the 2025 show.

BREAK (JoDee Putnins left)

Martha Lageschulte: We need to bring in new people, make it fun. Find fun things to do. We need to be open to look at why we do things the way we do. Not keep our ideas to ourselves.

- DSA events are favorites: agility, FastCAT, picnic, specialty.
- Challenge ourselves to step back and resolve disagreements with reaching out directly. Don't let things fester.
- People in the Samoyed community know they need to bring their best to DSA.
- Document knowledge and share it—prevent mistakes, not reinvent the wheel.
- More shadowing, i.e., Treasurer
- Encourage new members—be proactive in sharing why we've done things the way we have.

Not discourage new ideas.

- Donna Dannen-Frankie Trojan's grandson would like to be member (Thornton). Invite to agility trial, FastCAT.
- Reach out and follow up on invites.
- Hannah Deering's mother gave Pam Buhl dues for Hannah. Hannah is a junior from Ouray. They will need to fill out a membership application.
- Need to infuse club with younger energy.

#### **Committee Chairs**

Need yearly reports

#### **Vice President: Terry Walb**

No new applications.

New applicants typically submit their application first, then attend whatever meeting requirements there are. The bylaws state the converse—the application is submitted after attending two meetings.

#### **Recording Secretary: Lorrie McAllister**

Minutes will be more explanatory going forward, with fewer acronyms, titles, abbreviations. Publish quarterly glossary.

#### **Treasurer: Pam Buhl**

Trophies for FastCAT: new stuff, fun prizes

#### **Agility: Terry Walb**

Agility trial set up will be 3:30 pm on Friday, 1/17. Equipment vendor is now providing some new supplies so we no longer need to provide brown paper for the barrier.

#### **Awards: Kristi Schopfer**

Kris has agreed to continue to chair annual awards: fillable form made the job easier.

#### **Cheer: Donna Dannen**

Donna is continuing. She averaged two cards sent per month.

#### **Legislative Liaisons: Pam Buhl/Lorrie McAllister**

Both continuing. What issues do we want to prioritize? Issues coming up: Flatirons—bill McCormick/Sanders; Dougherty revising definitions. PACFA agency is up for sunset review soon.

CFDCO dues--\$75. Lack of updates and communications are a concern. Include note with dues payment.

**MOTION 25-005B**: Pay dues to CFDCO of \$75 and make a \$100 donation with a note requesting more communication (monthly updates)

Pam Buhl move, 2nd Rodney Martin. Passed unanimously.

AKC PAC possible \$100 donation to be considered at next membership meeting. Add donation, \$100.

CFDCO wants us to name delegate: Pam Buhl and Lorrie McAllister

#### **FastCAT: Tammy Linnert**

Workers' coupons will be taken for entries-see Tammy for more information. Hats offered for non-member workers. Workers must work 8 hours for jacket. New sign for photo backdrop. No whiteboard—line?

Worker sign-up sheet will be out after agility trial so we don't poach volunteers.

#### **Historian: Donna Dannen**

Donna wants to abolish this committee. Most materials will be available under Rex website.

We discussed how to go about this and who should receive materials from our library. Having an inventory sheet would help. Possible receivers include DSA members, Rex Library, SCA-Mary Drexler. Linda Kitzman—there's disagreement between SCA and Rex Library on how materials should be handled. We may ask DSA members how they want to handle historic DSA materials.

**MOTION 25-006B**: Abolish the historian/librarian role and during 2025 we will determine how we will disburse materials.

Donna Dannen move, Julie Morris 2nd. Passed unanimously.

#### **Hospitality/Summer Picnic: Linda Kitzman**

Linda will chair with Pam Buhl's help. Include informal match. On the Facebook page, ask if someone is considering qualifying for AKC judge's license. Date will be in June in Sterne Park. We will need to consider Buckhorn KC show date. Memorial Day shows interfere. Mid-May?

Additional activity considered—DSA hike at Staunton State Park in Conifer, CO. We will need everyone to sign liability waivers. Just Sammies. Open to non-members? Liability waiver. Good way to introduce people to club. Friendlier, more relaxed activity. Possible achievement of working points.

#### **Holiday Party: Tammy Linnert**

Tammy agreed to chair again!

#### **Public Education**

Waiting for Rachel Paulson to respond.

Weight Pull: reach out to JoDee Putnins about offering this through Greeley KC.

#### Sam-O-Gram: Martha Lageschulte

Martha will be continuing. Glossary of titles to be included on a periodic basis.

#### **Rescue: Sue Wangerin**

Sue will continue to chair. Donna Dannen is volunteering.

Pam Buhl—Dani chewed up donation checks. Pam will ask to re-issue.

#### Website: Terry Walb

Terry is continuing. Committee members have not been real active: JoDee Putnins, Calla Compton

and Lorrie McAllister.

- New content: Need to rotate pictures on the website for new content.
- Finding things: We're hoping to offer more help for users to find material—screen captures? Terry has some how-to's. Can we do hover descriptions? Site map?
- We need redundancy and training for committee members.
- Certain committees have had Google Drive access. What level of access should committee members have? Who determines (up to chair)? What level of access? View only, editor, people with link.
- If you have access and make a mistake, admit mistakes ASAP! Almost always it can be fixed/ restored.
- Organization of files and folders needs to be consistent. Consistent naming of files and folders is a problem. It becomes more important as we add more users.
- Google Drive: presently only officers and board members have access. Needs to be more of a central repository.
- We need an oversight committee for all IT.

**MOTION 25-007B**: Change the name of the website committee and rename it the Information Technology Committee encompassing the website, Google Drive and WhatsApp.

Lorrie McAllister, 2nd Donna Dannen. Passed unanimously.

Chair-Terry Walb, Co-chair-JoDee Putnins, Lori Elvera, and Lorrie McAllister are on the committee.

#### **Job Descriptions**

Last job descriptions document was in 2006. Each person will look at their current role. Start with old description and update it.

Include work plan elements, like task deadlines and frequency--yearly, monthly, etc. When Timeline—tasks due in January, etc.

How much time does the job require? What are the important tasks? What skillsets are required?

Goal is to complete new job descriptions by July 1; have rough draft for March meeting.

#### **Revisit By-laws**

New application form for membership, staggered terms, AKC language requirements, etc. Board will look at bylaws and discuss at March meeting.

#### **Zoom Meetings**

Voting meetings in person—judge nominations and votes (March-April), board nominations and voting (October and November).

**MOTION 25-008B**: Membership meetings will be held by Zoom in February, July and August. All other membership meetings will be held in person except as provided in the by-laws for weather or other special circumstances.

Julie Morris move, Tammy Linnert 2nd.

- Board meetings will continue to be held via Zoom except when in-person meeting is necessary. Some prefer not to meet on Sunday. Martha will look at her schedule.
- ammy asked if committee chairs can get the Zoom administrative password? Terry to look into this.
- Pam Buhl will set up alternate locations for in-person meetings:
- February Zoom
- March Wheat Ridge Natural Grocers

#### **Future change of DSA Specialty Date**

Tammy Linnert brought up the possibility of changing DSA specialty dates starting in 2027. Assume same location.

Douglas County Fairgrounds has opportunities in late March (mid-late) and April.

Discussion ensued:

- Some people come to DSA because of date.
- Some would favor additional specialty, but not moving date.

- Add a second specialty? Tammy will ask Lori E. if she wants to pursue.
- We used to affiliate with all breed shows. We had bad experiences with all breed shows, especially regarding judge choices. We decided to do standalone.
- Reasons to consider different time of year: costs—banquet, airfare higher, hotels higher.
- Other shows: York, PA; Ft. Worth, Atlanta specialties; HOA mid-March
- Timeline for discussion: earliest would be 2027. We're voting on 2027 judges in 4/25. Need to concern about people losing puppy eligibility.

Tammy Linnert will check it out and come back with more information.

Terry Walb handed out a business calendar draft.

We need to change the main DSA password for the website and ECWID.

MOTION 25-009B: Information Technology committee will change DSA passwords for main DSA accounts: website, Gmail, Google Drive, ECWID in January when the new board is seated starting in 2025.

Terry Walb move, Rodney Martin 2nd. Passed unanimously.

Increasing DSA Participation (Lorrie McAllister):

I'd like to head a project gathering input from members on how to make DSA more appealing to participate in.

- Feedback-Lori Elvera wants to check in with members.
- We can prepare talking points with work group via email and Zoom.
- Member contact needs to be a personal approach, like phone calls.

Since Kent Dannen has passed away, we are helping ensure that the dogs are cared for. Kent Dannen's three dogs need assistance from DSA/DSR.

One female, Grace, is currently with the show handler, Wendy Oelrich and her husband Barry. Wendy is not clear on DSR's role. Sue has not spoken with Wendy. Donna has spoken with her.

The two male dogs, Light and Moses, are at the vets office/boarding in Estes Park. All three are littermates approximately 10 ½ years old.





No one wants to think about getting old or sick, but as responsible dog owners, we must think about what would happen to our dogs if we became incapacitated or died. Everyone should have a written plan for how to care for their dogs in the event of an accident, illness, or death. Share this plan with the significant people in your life! Every day we hear about dogs that end up homeless or confiscated because the owner couldn't care for them. **Do not assume that family members will be willing or able to take on the responsibility of caring for your beloved pets!** 

#### Plan Ahead

Regardless of your health today, have a plan for your dogs in the event of temporary or permanent disability or death. The best way to do this is with an attorney familiar with these issues, but even an online Power of Attorney form, properly witnessed, is better than nothing. Post Emergency Care and contact instructions in an easily found location in your home or kennel. Authorize AKC registration/ownership to be made on your behalf if you are incapacitated or dead.

When preparing an estate plan, pet owners often fail to include provisions that provide for their pet's care upon the owner's death. According to a January 2022 article by ABC News, the number of pets surrendered to shelters due to the declining health or death of a caretaker is up from 7.3% in 2009 to 10.2% during the pandemic. Many of these cases could have been avoided had the pet owner asked their attorney to prepare a pet trust

#### Including Your Pet in Your Will

Once you have selected a caregiver for your pets, finalize the arrangement and include it in your will. This ensures that you are leaving formal instructions for who will take custody of the animals after your passing. You may also want to discuss setting up a trust with your attorney. This way you can leave behind funds for the caregiver to help cover the financial costs of caring for your pets.

#### What if Dogs Need Placement?

Time is of the essence if you die! Establish and confirm who should be contacted if your dogs would need immediate care. If necessary, identify a breed rescue and provide contact information if you do not have family, friends or club members who would help. Make sure that health records are available for those assuming care of your dogs.

Your designated caregiver should be trustworthy, responsible, and be able to provide a safe environment. Consider selecting a backup caregiver as well. Life can be unpredictable and the original caregiver's circumstances might change and become unable to care for your pet(s).

The responsible individuals should have: 1) keys to the home and kennel where the dogs are housed

2) your veterinarian's contact information, and information provided by you regarding permanent care of the animals.

Make sure neighbors, friends, and relatives know the names and contact numbers of the individuals who have agreed to be emergency custodians. Emergency custodians should also know how to contact each other.

Post "In Case of Emergency" signs on doors or windows with the number and type of animals inside. These signs will alert emergency responders during a fire or other emergency.

Inside the home and any kennel building post a listing of the emergency contacts. Inside the home attach a pet emergency packet to the refrigerator, or other prominent location. A copy of a Pet Care Durable Power of Attorney and/or Pet Trust document (if in place) should be included.

Summary: As difficult as it may be to think about, there's a chance your dogs might outlive you or you die unexpectedly. What happens to pets when their owners die and there is no plan in place? Thousands of pets are placed in animal shelters every year when their owner passes away. It is estimated that the exact number is between 100,000 and 500,000 animals per year. Of those, roughly 60 percent end up being euthanized when an adequate home cannot be found. Is that the outcome you want for your dogs?

Please plan ahead.

# In Case of an Emergency

Who would take care of your dog if you were hurt and unable to do so? To make sure vital information regarding your dog is easily accessible to others, take a few moments to fill out this emergency information sheet.

List two or three people as contacts in case of emergency. Include the contact's name, address, and telephone number. Make sure at least one of the contacts has a set of your house keys.

You may also want your attorney to draft a written statement, which gives immediate custody of your dog to a designated individual with that individual's consent. Notify that individual of his or her responsibility, and put his or her name, address, and phone number on your emergency information sheet.

Attach a recent photo of your dog to the information sheet to help others locate your dog if it should wander off.

Put the information sheet on your refrigerator or other prominent spot in your house. You may also want to keep similar information in your wallet. If you are unable to care for your dog due to an accident or emergency, someone will be able to follow the instructions on the sheet to provide necessary care.
