Top 10 Medications Your Dogs Should Never Take

Every year thousands of pets are poisoned by medications that are intended for human consumption. The Cat Channel printed a list of the most common drugs that are poisonous to pets.

The Pet Poison Helpline which is a 24-hour service staffed by veterinary professionals, reported that almost half the calls they receive involve pets that have ingested either over-the-counter or prescription medicines meant for people.

Here is the list of the 10 most common medications reported to the Pet Poison Helpline:

- 1. **NSAIDs** (e.g. Advil, Aleve and Motrin) Common household medications called non-steroidal anti-inflammatories (NSAIDs) top the list. The names include ibuprofen (e.g., Advil and some types of Motrin) and naproxen (Aleve).
- 2. **Acetaminophen** (e.g. Tylenol) Even though this drug is safe, this is not true for pets especially cats. One regular strength tablet of acetaminophen may cause damage to a cat's red blood cells.
- 3. Antidepressants (e.g. Effexor, Cymbalta, Prozac, Lexapro) While occasionally used in pets, overdoses can lead to serious neurological problems such as sedation, incoordination, tremors and seizures. Pets seem to enjoy the taste of Effexor and often eat the entire pill. One pill can cause serious poisoning.
- 4. **ADD/ADHD** medications (e.g. Concerta, Adderall, Ritalin) Minimal ingestions of these medications by pets can cause life-threatening tremors, seizures, elevated body temperatures and heart problems.
- 5. **Benzodiazepines** and sleep aids (e.g. Xanax, Klonopin, Ambien, Lunesta) About half of the dogs

who ingest sleep aids become agitated instead of sedate. In addition, these drugs may cause severe lethargy, incoordination and slowed breathing in pets.

- 6. Birth control (e.g. estrogen, estradiol, progesterone) Large ingestions of estrogen and estradiol can cause bone marrow suppression, particularly in birds. Additionally, female pets that are intact are at an increased risk of side effects from estrogen poisoning.
- 7. **ACE Inhibitors** (e.g. Zestril, Altace) Pets ingesting small amounts of this medication can potentially be monitored at home, unless they have kidney failure or heart disease.
- 8. **Beta-blockers** (e.g. Tenormin, Toprol, Coreg) Small ingestions of these drugs may cause serious poisoning in pets. Overdoses can cause lifethreatening decreases in blood pressure and a slow heart rate.
- 9. **Thyroid hormones** (e.g. Armour desiccated thyroid, Synthroid) Large acute overdoses in cats and dogs can cause muscle tremors, nervousness, panting, a rapid heart rate and aggression.
- 10. **Cholesterol-lowering agents** (e.g. Lipitor, Zocor, Crestor) Most "statin" ingestions only cause mild vomiting or diarrhea. Serious side effects from these drugs come with long-term use.

Exhibitor Rule Changes—Effective 2010

Chapter 11, Section 1.

No dog shall be exhibited in a licensed or member dog show, except for dogs entered in the Miscellaneous Class unless it is either individually registered in the AKC Stud Book, or individually registered with a foreign registry organization whose pedigrees are acceptable for AKC registration. A dog with an AKC limited Registration shall be ineligible to be entered in a breed competition in a licensed or member dog show.

An unregistered dog with an acceptable foreign registration that is individually registered with a foreign registry organization whose pedigrees are acceptable for AKC registration may, without special AKC approval, be exhibited in licensed or member dog shows that are held not later than 30 days after the date of the first licensed or member dog show in which the dog was exhibited, but only provided that the individual foreign registration and name of the country of birth, are shown on the entry form; and provided further that the same name (which in the case of a foreign-registered dog must be the name on the foreign registrations) is used for the dog each time.

No dog that has not been individually registered with The American Kennel Club when first exhibited in a licensed or member dog show shall be eligible to be exhibited in any licensed or member dog show that is held more than 30 days after the date of the first licensed or member dog show in which it was exhibited, unless the dog's individual AKC registration

number is shown on the entry form, or unless the owner has received from The American Kennel Club an extension notice in writing authorizing further entries of the dog for a specified time with its individual foreign registration number. No such extension will be granted unless the owner can clearly demonstrate, in a letter addressed to the Show Records Department of The American Kennel Club requesting such extension, that the delay in registration is due to circumstances for which he is not re-

Such extension notice will be void upon registration of the dog or upon expiration of the period for which the extension has been granted if that occurs earlier, but upon application further extensions may be granted.

FREQUENTLY ASKED QUESTIONS

Q:Why change the requirements? A:The change was made to encourage exhibitors to register all puppies eligible for AKC registration.

Q:Must the dog have individual AKC registration prior to the closing date of the event? **A**:Although it is best to register the dog well before the event, the registration must only be processed by AKC prior to the starting date of the event.

Q:Are Puppy Classes affected? A:Yes, even dogs in puppy classes must now be individually registered.

Dogs may not be exhibited on litter registration at licensed or member events.

Q:Do Foundation Stock Service (FSS) breeds and Miscellaneous Class breeds have to be individually registered to compete as well? A:Yes, all dogs, including Foundation Stock Service breeds & Miscellaneous Class breeds must enrolled in the AKC Foundation Stock Service® prior to the day of the event to com-

Q:Are all AKC sports affected? A:Yes, all dogs competing in AKC performance events, companion events and conformation shows are required to be individually registered before competing in the event.

Q:May dogs with foreign registration compete? A:Dogs individually registered with an AKC recognized registry (see: http://www.akc.org/ rules/special_registry_services.cfm) may exhibit for up to 30 days after the date of the first AKC event in which it was exhibited. After 30 days time the dog must have received AKC registration or have applied for and been granted an extension from AKC Event Operations in order to continue exhibiting at AKC events.

Q:May dogs with Limited Registration exhibit? A:Dogs with AKC limited registration are not permitted to exhibit in conformation shows (except in Junior Showmanship Classes) but


