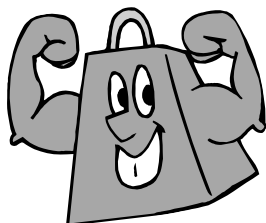

Bob has been a Samoyed breeder, exhibitor, and Sammy enthusiast since 1984. He started weight pulling in 1989 and has been an IWPA weight pulling judge since 1999. He was on the Samoyed Club of America's committee that wrote the SCA weight pulling rules and on the National Sledding and Weight Pulling awards committee. He is currently the SCA Chief Judge Chairman who tests people who want to become a weight pulling judge. He has put on the SCA's National weight pull competition for the last 8 years. Bob comes to us with lots of knowledge and insight.

This seminar will begin at 9:00 am and end by 4:00 pm, with a 1 hour lunch break. (Lunch is not provided, but there are plenty of restaurants nearby). This seminar will be held indoors in a heated facility with plenty of room to crate your dog. Chairs are available or bring your own comfortable chair. Please pick up after your own dog.

The morning will include the basics of weight pulling, IWPA rules, understanding the equipment, safety issues, canine structure and conditioning, and what you need to start out. Handouts are included.

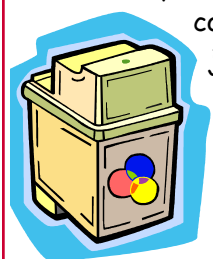

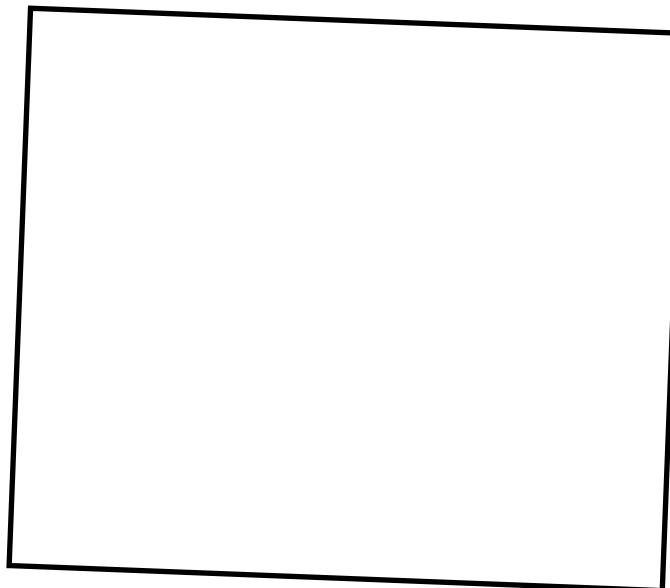
