Congratulations on earning an award from the Denver Samoyed Association!

DSA awards are given to recognize AKC and SCA sanctioned conformation and performance titles earned by club members' dogs, and will be presented at the Monday, December 19th Holiday Dinner at Simm's Steakhouse.

Awards are earned from January to December 31st of each year.

The Awards are a 6" x 8" walnut plaque engraved with your kennel name (or your name), and given only with your first award; as well as a brass hang tag to honor each of your dogs that earned a new title this year.

The cost is as follows: DSA and the recipient shall split the \$30 cost of the plaque and its engraving. The hang tag's cost and its engraving shall be paid totally by DSA. Additional hang tags may be purchased (\$4.50 each) by the owner or breeder and paid for at their expense.
