AKC Fights to Protect Hobby Breeders

AKC has filed a brief in the latest round of the long-running legal battle between Doris Day Animal League (DDAL) and the US Department of Agriculture (USDA). DDAL's lawsuit seeks changes to make residential breeders who sell dogs directly to the public (including hobby breeders) subject to federal licensing and inspection requirements under the Animal Welfare Act (AWA). Although AKC strongly supports the humane care and treatment of animals and the vigorous enforcement of humane treatment laws, the AKC strongly opposes reinterpreting the AWA to require the licensing and inspection of residential breeders of dogs.

A federal judge ruled in favor of DDAL in July 2001, and the government is now appealing that decision. Although AKC is not party to the lawsuit itself, its "friend of the court" (or amicus curiae) brief supports the gov-

ernment's position that the Animal Welfare Act was intended to cover only wholesale dealers of dogs, not those that sell directly to the public. The AKC contends that legislative and regulatory history of the AWA support the USDA's exclusion of residential breeders, and that the exclusion should remain unchanged for a whole series of public policy concerns.

Among the key points in AKC's brief:

- Such a change would bring a massive number of homes under federal licensing. Not only would the number of licensees increase 1800-3300 fold, but the body of licensees would constantly change (unlike wholesalers, the majority of home breeders don't breed every year).
- The focus of the AWA would shift away from the facilities posing the greatest risk.
- · Residential sellers of dogs

- are already subject to a high degree of regulation by others: the buyers themselves, breed registries like the AKC, local and state authorities.
- Most of the complaints of deplorable conditions by breeders are already violations of the AWA.
- It is an unwarranted invasion of privacy to go into breeders' homes.
- The care standards established for wholesale dealers of dogs under the AWA are not appropriate for residences. These standards address care for high numbers of dogs; include specifications and procedures for large-scale facilities; and require materials and procedures that are difficult, unnecessary, and virtually impossible for small breeders to follow.
- The changes mandated by the DDAL lawsuit will in fact

Tennessee Judge Slam-Dunks Puppy Mill Owners

MEMPHIS, Tenn. (USA) - Last week, The Commercial Appeal reported on a recent Tennessee Court ruling that was "worthy of a standing ovation." Judge Alan Glenn, rebuked an appeal of a couple from Humboldt who had bred and kept as many as 350 dogs sick and starving in filthy kennels. Not only did Judge Glenn deal very sternly with the offenders, he delivered an excellent oratory that ought to be framed above the door of every court that handles animal abuse cases. He said:

"The Court finds that Judy Fay Johnson and Stanley Paul Johnson have been found guilty of 11 counts of cruelty to animals. Bonds are set at \$1,000 in each of the 11 counts, which was done by a jury of good and lawful citizens of Gibson County.

"Over 350 puppies and dogs were victims of this gross violation of the law. The victims of this crime were animals that could not speak up to the unbelievable conduct of Judy Fay Johnson and Stanley Paul Johnson that they suffered. Several of the dogs have died and most had physical problems such as intestinal worms, mange, eye problems, dental problems and emotional problems and socialization problems

"Since dogs have entered domestic service of human beings, they have given solace and companionship when needed. They have helped hunt, guard flocks, and in ice and snow have pulled sleds.

"They have rescued people when lost in snowdrifts. They act as police in sniffing out crimes, and they become eyes for those who cannot see. They guard homes and possessions. All this, these creatures do for kind, humane treatment

"Watching this video of the conditions that these dogs were subjected to was one of the most deplorable things this Court has observed in the 22 years in the course of being on the bench.

"And though, Judy Fay Johnson, you urge this Court to take into consideration the mitigating factors that you've been sick up to two years prior to them being rescued from your care. You say you've

been sick. You talked about reducing the population, but the only thing you did was sell puppies.

"The Court finds that you have a previous history of criminal convictions or criminal behavior, that the offense involved more than one victim, that the victims were particularly vulnerable, that you have a previous history of unwillingness to comply with conditions of a sentence involving release into the community, and that you abused the position of public or private trust.

"The Court further finds that you were charged with this exact same charge in 1993, and after a period of probation, the matter was dismissed.

"Judy Fay Johnson, you're sentenced to 11 months and 29 days in each of the 11 counts of cruelty to animals. These will be run concurrent. Further, this Court finds that probation would not serve the ends of justice, nor be in the best interest of the public, nor would this have a deterrent effect for such gross behavior.

"Therefore, you, Judy Fay Johnson, shall serve six months of your sentence on condition that you make restitution to the Dyersburg Humane Society for \$3,242 for the expenses involved in freeing those

dogs from their purgatory and your payment of the fine and costs in full. You are further prohibited from ever running or owning any animal kennel or owning any animal as a pet.

"Stanley Johnson, the Court finds that your offenses involve more than one victim. The victims were particularly vulnerable. You treated the victims with exceptional cruelty. You abused the position of public or private trust. You were charged with the exact same charge in 1993 that after a period of probation was dismissed.

"You are sentenced to 11 months and 29 days in each of the 11 counts. You shall serve 90 days of your sentence on condition that \$3,242 be paid to the Dyersburg Humane Society for the expenses involved in removing the helpless dogs from your custody. You are further prohibited from ever running or owning any animal kennel or owning any animal as a pet.

"There are those who would argue that you should be confined in a house trailer with no ventilation or in a cell three-by-seven with eight or ten other inmates with no plumbing, no exercise and no opportunity to feel the sun or smell fresh air. However, the courts of this land have

that such treatment is cruel and inhuman, and it is. You will not be treated in the same way that you treated these helpless animals that you abused to make a dollar."

Pre-titled entrants must submit an SCA tally sheet showing 100 points accrued in any of the categories contained in the SCA working title program during the 12-month period prior to the closing of entries. Electronic mail or fax is acceptable.

FEE:

Entry fee is \$12.00 for each Samoyed entered in the Working Samoyed Sweepstakes. Samoyed need not be entered in another class at the Specialty show. Entries shall be made at the same time & on the same form as the Regular Classes. Indicate "Working Samoyed Sweepstakes" and the class division in the space marked, "Additional Classes."



hurt consumers. The regulations will drive small breeders out of the hobby and more consumers will be forced to turn to those dealers who are interested solely in profit. The changes will thereby encourage the puppy mills and scurrilous breeders the AWA was designed to prevent. The changes undermine the basic purpose of the Act.

 The entire 30-year legislative history of AWA supports including residential sellers of dogs under the "retail pet store" exclusion. The USDA issued an Advanced Notice of Proposed Rulemaking in 1998 and after receiving tens of thousands of public comments, decided that changing the definition of animal dealer to include residential breeders was neither practical nor appropriate.

The United States Court of Appeals is scheduled to hear the case on November 4, 2002.


