Dog Days of Denver

You spring for the healthy dog food, arrange doggy play dates, and treat your pup to the occasional mountain getaway.

What more can pooch parents living in Denver - one of the most populist canine communities in the country - do to improve life for their dog and for themselves?

Journalist and small-business owner Kim Jackson has a few ideas and wants to share them with as many pet-preoccupied people as possible.

"I got the first dog of my entire life five years ago," says Jackson, 44. "I suddenly met tons of people out walking their dogs and thought 'wouldn't it be nice if we had one source to talk about what's (for dogs) in the Denver area?'"

In May, she launched *Dog Days of Denver*, a 24-page glossy magazine with a sunny logo featuring the head of Jackson's collie/German shepherd/chow mix, Simba. The magazine is intended for people "making the most of life with your dog."

There's an array of national dog magazines, as well as local newsletters for dog owners, but *Dog Days of Denver* is currently the only magazine just for Mile High pooch people.

Denver is well-suited for such a magazine, according to

market research Jackson conducted before starting *Dog Days of Denver*. Some tidbits she learned about Denver dog owners include:

- They typically own their home and earn \$60,000 or more a year.
- They willingly go into debt for their dogs, spending discretionary income on veterinary care, food, grooming, toys, sitters, portraits and gifts for birthdays and holidays.
- Almost 80 percent of Denver dog owners have more than one dog.
- More than 70 percent are age 40 or older.
- Fifty-five percent have children in the home.

The inaugural issue of *Dog Days of Denver* included an

8/19/02 – Membership Meeting

Martha Lageschulte called the meeting to order at 7:20 PM.

There were no changes to the July minutes.

President's Report - Martha Lageschulte
Martha received a notice from AKC that was sent to all club President's and show chairpersons on a club communication kit they are putting together. It contains information on how to successfully work with the media.

Secretary's Report - Andi Mast

Corresponding Secretary's Report - Jane Reller
Jane received an e-mail on a dog fashion show to be held at Aspen Grove on September 14th to benefit Denver Dumb Friends League. Channel 2 will be filming.

We received permission to hold our supported Sweepstakes entry on February 15, 2003 with Robin Hobbs as our judge.

A flyer was passed around on in home training and a flyer from AKC on banners they have available.

Treasurer's Report - Thalia Peletis
Our bank assets are over \$20,000. We have \$2,300 in grocery certificate assets. To date we have made \$933 from our grocery certificate sales.

At the last board meeting, the agility committee was formed and Jane Reller was named as chairperson.

Agility Committee – Jane Reller
We are set for our match this Saturday. Registration starts at 7:30. We will begin set up at 7:00. Thalia has done a great job on creating a database where all of our entries have been entered. This will allow us to generate all our reports following the match. Entry confirmations were mailed August 8. We exceeded our 50-dog limit and returned 8 entries. We have gate sheets, scribe sheets, ribbons, and labels. Following the match we will submit to AKC a marked catalog, trial secretary and match secretary reports.

Supported entry 2003 with Plum Creek – Julie Morris

At the last meeting, there was a lot of interest in holding a supported entry in 2003 but we did not yet have a chairperson. Last year we did not begin our process until October. Martha received a call from Heidi Nieman (also a Plum Creek member) on Tuesday, July 23 saying that Plum Creek needed to know immediately if we were going to hold a supported entry. Martha contacted Fran Strayer on the evening of the 23rd. Fran is the Plum Creek show chairman for the weekend. Fran told Martha that Plum Creek needed to know by Monday, July 29th if we were doing a supported entry and on which day, Friday or Saturday we would be doing it. Fran said we did not need an answer on sweepstakes until the end of September. On July 24th, Martha e-mailed club members asking for their vote for which day we should hold the supported entry. The judge on Friday is Nancy Russell and the judge on Saturday is Chris Walcovicz. Martha asked for a response by Monday July 29th. On July 24th, Julie Morris agreed to be the committee chairman. On the 25th Fran called Martha and asked if we had made a decision. When Martha spoke with Fran that evening, she reminded her that she had given us until Monday, July 29th to provide her with an answer. Fran then asked who our sweeps judge was. This did not allow enough time to make nominations and vote at a regular club meeting. Martha spoke to several board members who agreed that Robin Hobbs who had been nominated for the Specialty match would be an appropriate choice if she were available. It was by 1 vote that we would have our supported entry on Saturday, February 15th. There have been several phone calls and e-mails between Fran, Julie and Martha regarding the correct date and we have confirmation from AKC for the Saturday date. Plum Creek said that CKC had sat on the paperwork and they were only given the very short notice to contact clubs and provide the information.

Plum Creek will be offering red glass trophies for Valentines Day. We can purchase our trophies from them for the supported entry. Last year we used trophies from previous DSA Specialties. We do not have many trophies left from our previous Specialties. Julie will find out additional information and bring to the club. The deadline we have been given is September 18th. It was discussed that AKC now requires a detailed description of trophies to be in the premium list.

It was noted that Robert's Rules of Order allows the board and officers to make emergency decisions for the club, and it is recommended that this decision be ratified at the next meeting. It was motioned and approved to hold a supported entry at the Plum Creek show on Saturday February 15th with our sweepstakes judge being Robin Hobbs.

Meeting was adjourned at 8:30 p.m.

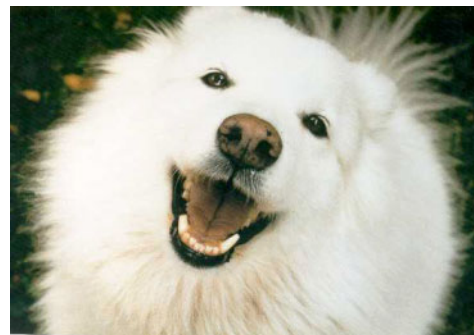

interview with local celebrity vet (and part-time comedian) Kevin Fitzgerald, an article discussing the pros and cons of dog parks, another with information about breeding, and a special section about dog day care. Pet stores and businesses advertise in the magazine. Jackson also dedicates space to her "non-profit partners" such as Harrison Memorial Animal Hospital, the Denver Dumb Friends League and the Humane societies of Longmont and Boulder Valley.

"If someone is on the fence about whether or not to keep their dog, I want them to read the magazine and see there are ways to handle any issue," Jackson says. She also wants the magazine, which has a circulation of 20,000, to provide information about dog activities and resources specific to Colorado.

Of course, no magazine is complete without a community calendar and an astrology page. "Which Cosmic Canine is in your life?" astro-columnist Marilyn MacGruder Barnewall asks.

Jackson says her readers seem to enjoy

the *Dogs Day of Denver* centerfold, which looks like a doggy family photo album. In one picture, a white-haired woman lounges in her living room with a long-haired, blond mop in her lap. "I love Frankie... What did I ever do before him?" reads her quote beneath the photo.

Other photos show dogs perched in front of picturesque Rocky Mountain vistas or playing in grass with their favorite kid. And a newlywed couple submitted a snapshot of their dogs decked out in wedding-day formalwear.

"Our dogs are part of our family," the couple wrote. "They even dressed the part when we were married."

Toni Mathiasen, a retired saleswoman who lives in Littleton with her husband, Howard, and their yellow Labrador retriever, Winston Churchill, snapped up one \$18.95 *Dog Days of Denver* subscription for herself and two more for family members.

"I find the articles useful, and the ads are good, too," says Mathiasen, adding that the magazine's colorful cover and layout immediately drew her in.

New U.S. Postal Stamp

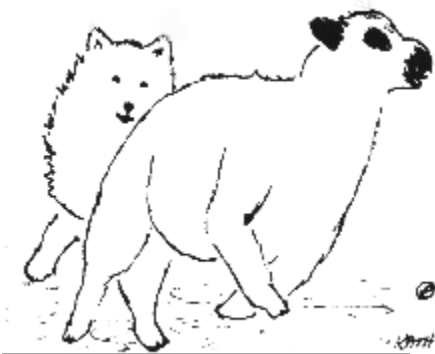
This stamp will be issued at the new first-class rate of 37 cents.

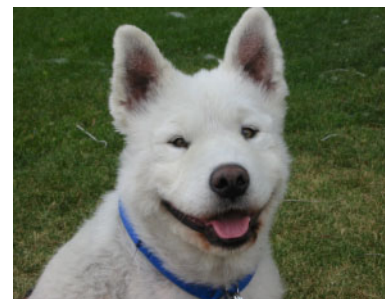
