CSU Vet School - #2 in the Nation

COLORADO STATE UNIVERSITY VETERINARY MEDICINE PROGRAM RANKED SECOND IN THE NATION IN LATEST SURVEY BY U.S. NEWS GRADUATE GUIDE

FORT COLLINS--Colorado State University's Veterinary Medicine program was ranked second in the nation, according to U.S. News & World Report's annual 2001 Graduate Guide.

The veterinary medical program, which awards Doctor of Veterinary Medicine degrees, has consistently ranked among the top veterinary programs in the country. In the latest survey, Colorado State was ranked No. 2 behind Cornell University and tied with the University of Pennsylvania. Colorado State was last assessed in 1997 and ranked fourth.

"We like to be known as the best college of veterinary medicine in the country," said Dr. James Voss, dean of the College of Veterinary Medicine and Biomedical Sciences. "Our goal has always been--and continues to be--to prepare our students to be the best in their profession: insightful, confident, caring and with sharp

Thank You from ICU staff at Littleton Hospital read: "Dear Samoyed Association, Thank you so much for your thoughtful gift of \$150. We intend on spending it on a new TV/VCR for patient education. We appreciate your generosity."

Earl Miner the Chairman of Colorado Dog Fancier's Association legislation committee sent letter stating, "Recent events have left Colorado dog clubs and organization in a state of uncertainty about the future of dog shows in our area. The Dept of Agriculture recently began in earnest the enforcement of PACFA (Pet Animal Care Facilities Act). A law that lay dormant for 5 year that among other issues would require licensing for the transport, housing and handling of dogs within our state. This law effects out of state exhibitors traveling to Colorado. The Colorado Dog Fancier's were caught off guard by the unexpected position of the Dept of Agriculture. A few individuals' rallied resources and a strategy were formulated. We are still in danger of loosing our privileges as a dog fancier community. As stated by the AKC, 'Colorado has some of the toughest dogs laws on the books and you must ban together and address these issues'. Colorado Dog Fanciers Association.

Janet Fox Stevens has represented our cause thus far without any compensation and with conspicuous absence of the dog community. Because of her generous volunteer activity she has proposed an amendment to the PACFA law and received

support from the AKC along with a few dog clubs. CDFA is asking for your support and strongly encourages you to attend this special meeting. Serious issues will be discussed regarding the future direction of our sport. If you or a representative from your association are unable to attend please contact Earl Miner.

As of this date Janet has not asked for any compensation, she is a lobbyist for the dog community. In the future dog clubs may be asked to support her either financially or with letters. (Clarification of the law licensing of people transporting dogs into state, ok if you are handing own dog. DSR has license as it transports more that 75 dogs per year cost?)

AKC has a legislative liaison program to encourage dog owners and clubs to get active with legislature because nation wide there are more and more laws against dogs.

Yates. "This latest ranking confirms our own belief in the quality of the program and its extraordinary attention to service."

Students in the College of Veterinary Medicine and Biomedical Sciences can enroll in a variety of academic programs including undergraduate, graduate and the professional veterinary medical program as well as internships, residencies and post-doctoral activities. The college includes 536 professional veterinary students and 140 professional veterinary faculty.

The Veterinary Teaching Hospital also houses the Animal Cancer Center and the Argus Center for Human-Animal Bond Resources. Animal Cancer Center veterinarians and staff use the latest technology, chemotherapy and radiation to treat companion animals and have pioneered the use of limb-

sparing surgery and hyperthermia therapy, among other treatments. Some of these techniques have been transferred successfully to treat human cancer patients.

The Argus Center operates counseling services for pet owners and education for professional veterinary staff seeking a holistic approach to veterinary medicine that treats not only an animal's disease and pain but recognizes the special relationship with a human family.

Each year, U.S. News & World Report re-evaluates graduate programs in five major disciplines: business, education, engineering, law and medicine. The rankings are achieved by using objective measures, such as entering students' test scores and faculty/student ratios, and reputation ratings drawn from inside and outside of academia. Deans, program directors and senior faculty are asked to judge the overall academic quality of programs in their field on a scale of 1 ("marginal") to 5 ("distinguished").

Colorado State has also been ranked in the top third of the 100-best public universities in terms of quality of education and affordability by Kiplinger's Personal Finance Magazine. In addition, the Templeton Foundation has designated Colorado State as a "character building" institution.

When she went to relieve herself it didn't hit the ground. We are talking the most disgusting do I have ever seen.

Five hour drive home with her in the crate in the back of the truck. Stopped three times to spray her for flees. I arrived at 10PM. I had to work the next morning so I really needed help. Months have passed She has been living here growing her coat back. Her first public appearance was in a Christmas parade here in Florida. Some of the club members thought she was my female that I take everywhere, Baby. Baby was there but I had a nine year old friend handling her. I thought that was great compliment for Smoodle.

Today Smoodle left my home. Months of work have finally paid off. Smoodle adopted a family from Ft. Lauderdale Florida. A very nice couple who will give her what ever she desires. I am very happy that she has found a good family to care for her. She is under two years old and her first year was hell. Let's hope the rest of her years are full of joy.






