#### Do You Know a Correct Sammie Coat?

No, it's not one spun of Sammie fur that hangs in your closet. At the Clinton Iowa show, Judge Dr. R.D. Smith made several comments to exhibitors about coats. Some participants didn't quite understand what he meant, so there were discussions after the judging about what IS a proper coat. Someone thought Dr. Smith's comment about coat meant it was too short, when in fact that particular Sammie has a proper coat that stands out from the body. What I thought was incorrect was that the guard hairs were too soft, especially for a male. So I thought I would review what I could find on coat.

So, first, let's go to the standard, which says:

#### -President's Report. Andi Mast

Andi had requested and received a copy of DSA's insurance policy and recent addendums.

- -Treasurer's Report. Carolyn Bateman.

General Fund - \$2,935.49. Rescue Fund - \$1,620.09.

#### -Unfinished Business:

#### DogTown Status:

- Jim Alford's, former Dogtown Kennel owner, recently had computer problems and lost his bookeeping files, including what DSA still owes him. Deb offered to investigate and report all outstanding bills owed to Dogtown. See the following article for Deb's detailed report.
- Board agreed to pay \$1100 dollars to Jim Alford. This would leave \$520.09 in DSR treasury.
- Jim Alford officially turned over Dogtown to new owners as of June 15<sup>th</sup>, 1997.
- The current bill to date, to the new Dogtown owners is \$132.
- The Board agreed that boarding fees from Dogtown will be paid in a advance, once a month. The new boarding fee is \$4.25 a day (\$.25 more). Deb will keep track of expenses on behalf of DSA/DSR, since their bookkeeping has also been unreliable.

#### Breeder's Showcase:

- The showcase will be held at Buckhingham Square Mall on July 26<sup>th</sup> and 27<sup>th</sup>.

#### All-Breed Match.

- The match will be held at Morse Park on August 24th.
- We have received a complaint from the Basset Hound President, because their fun match is also on that same date. They had felt by notifying CDFA, which keeps an informal list of fun matches in the area, they exclusively secured that date. There is no official method in regards to securing dates for fun matches. Our date was chosen based on available dates, meaning no scheduled local AKC dog shows, and the fact we used this weekend previously. The board agreed that canceling is not an option, particularly since we have had flyers out for over a month. Andi said she will talk again to the Basset Hound Club President. Andi will also find out why we haven't received our CDFA newsletter in some time. (It turns out DSA has not paid our dues. We will have the dues renewed).
- We need 25 entries at \$5 to break even.

- We will not offer agility due to logistics and cost.
- Other ideas were discussed to raise money at this event. They included offering baskets of animal or human goodies. We would then raffle the baskets, provided we have our raffle license by then. Also, we thought we could invite the animal communicator.
- The Board will pass out a sign-up sheet for 14 stewards and 4 registration people, at Monday's membership meeting.

- Currently, each bus is short 5 couples. Each bus holds 47. Please try to find more interested parties to attend.

# Do You Know a Correct Sammy Coat?

(Continued from page 1)

"The Samoyed is a double coated dog. The body should be well covered with an undercoat of soft, short, thick, close wool with longer and harsh hair growing through it to form the outer coat, which stands straight out from the body and should be free from curl. The coat should form a ruff around the neck and shoulders, framing the head (more on males than on females). Quality of coat should be weather resistent and considered more than quantity. A droopy coat is undesirable. The coat should glisten with a silver sheen. The female does not usually carry as long a coat as most males and it is softer in texture."

For further clarification, the following comments and excepts were sent by the Judges Committee. This first set was contributed by Larry Mackai:

"It is not easy to determine quality without feeling the coat. People at the show are not anxious to have you feeling their dogs after they are groomed for the ring, but maybe afterwards you could ask to feel the coat. Keep in mind that there are "enhancements" that can be used, but coat quality does not come from a bottle, and it is important to know that the true quality, especially as you look for possible breeding stock.

Why does that matter if a dog has a longer, softer coat than is described in the standard? This is best answered at an outdoor show in the rain. Those dogs with the correct texture coat will shed the water, while the others will absorb the water and become wet. This was even more critical for those dogs in Siberia who had to keep out the cold in order to survive. A dog with a softer coat will also attract 'snowballs' in their coats, legs and feet, making it more difficult for them to survive in the harsh climate.

It would seem that as the popularity of working events grows among fanciers in our breed, the more the function of a quality coat will become more important."

# And from Robert Ward on Interpretation of the Standard:

"...A coat that naturally resists cold, snow, mud and dirt with one good shake. Not so long, flat and soft that snow will pack into it in layers...

A typey Samoyed does NOT HAVE...[it's a list, but regarding coat] \*Long, droopy, soft coat....

A proper typey Samoyed DOES HAVE:....Sufficient coat and ruff to frame the body with pleasant curves, with texture that is on the harsh side, erect to hold out snow and moisture, and double-coated at appropriate time of the year.

# More from the Judges Committee...this information was written by Jill Smoot:

"...Quality of coat should be weather resistant and considered more than quality. A dog in the process of blowing, who exhibits proper coat quality is more desirable than a fully coated dog with improper coat quality. Stand off coat is another very important point.

An outer coat comprised of longer hair will lie down, hold the ice and snow and weigh the dog down. There is a point of too much coat, as you can have too much head, too much bone, etc. Once again, think of function. Other points on coats:

- Most puppies will have very soft coats, known as puppy fuzz.
- Some puppies will not lose all of their puppy coat until about 1 year of age.
- Some puppies will have a profusion of curly coat on their backs under the tail. This will often make them look very high in the rear. It is also a temporary puppy coat condition. Puppies who have waves in the coat on their back generally turn out to have a ton of coat as an adult. Frequent baths will change the coat texture and durability.
- You should be able to see the silver tips in the coat in natural light. An absence of silver tips may be the result of scissoring.
- The only parts of the Samoyed that should be scissored are: feet (bottom and sides), and hocks.
- A Samoyed can carry a plush, sculptured looking coat and not be scissored.


Thanks so much to the Judges Committee for the previous information. One last part I found written by Patricia Gillam in "The Samoyed Book" (1984, Hoflin Publishing Ltd.) which is in our library:

"The beauty of the Samoyed is largely derived from the appearance and condition of its coat; its glistening shine is the first thing that catches the eye and stimulates one's interest in the breed. To maintain the coat's elegant sheen is not an easy achievement. Proper diet frequent brushing, and diligent care are essential for preservation of it's loveliness....

In order to achieve an ideal texture or to restore a dull or damaged coat, various supplements can be used to augment the diet. Some widely used remedies include cottage cheese, egg yolk, wheat germ oil, brewers yeast, zinc, kelp, and other commercial products."

Pam Landers made a wonderful point that a proper Sammie coat takes longer to get wet when you bathe it. So the next time the grooming seems to go on forever, be grateful for that proper coat! Thanks to judges like Dr. Smith who recognize and reward proper coat, our breed is in good hands!

Editor's Note: The following article is based on the program presented by Alan Odum, our local AKC Representative, at DSA's 7/21/97 Membership Meeting. The article also includes the Questions and Answers posed throughout the program.

#### Topic: Protesting Another Dog's...

#### Eligibility:

"For whatever reason you want to have another dog measured that's in the ring, you have to make your protest while your in the ring and before the judge examines and moves every dog in that class. So, I would recommend that if you are in the ring, and you want to protest a dog for height eligibility or for a disqualification, that you do it the first thing when you come into the ring. You let the judge know that you would like number so and so measured. The judge has to measure that dog. If you are in a large class and a judge splits that class, and you leave that ring and the dog you want measured is left in the ring, you can not protest that dog, because you are not in the ring. If your an owner of one of the dogs in the ring, if you want to protest the height of one of the dogs in the ring, you can't do it. You have to be in the ring, competing against the dog. You may tell your handler to make a protest on a certain dog, while they are in the ring. We also encourage you if you have a breed that is a measurable breed, the judges when they set that wicket, the judge is suppose to let you see what that height is set at. If the judge doesn't show it to you, then you ask the judge to let you see it. We also encourage a judge to carry a measuring tape with them, to check the accuracy of that wicket. Some of the wickets, after years of use, are not that accurate."

**Q**: Does the same hold true, if you are questioning a Bred-By-Exhibitor, if they are in fact the breeder of that dog?

A: You may bring that to the judge's attention. However, the judge does not determine eligibility in classes such as puppy, bred-by, or novice classes. You as the exhibitor, should go the AKC Rep or superintendent and let them know that particular case, that the dog was not shown by one of the breeders. We would then send a letter to the AKC office and any awards that dog may have won, would be taken away.

**Q**: Does the judge then have the right to ask the age of a puppy?

A: That is one question the judge may ask of any dog that is being shown in any class. It may be an immature dog, for instance is it a puppy entered in the open class or is it a 3 or 4 year old dog? In Poodles, if a dog comes into any class except Puppy class, in a Puppy Clip, then they have to ask the age of the dog. Otherwise, it's a disqualification if it's not a puppy. AKC encourages the judge, instead of asking the handler, they ask the steward for the age. If you are the steward, then you give the judge the birth date and let the judge figure out how old the dog is themselves.

#### Disqualifying Fault:

"This includes deafness, blindness, not two normal testicles. The exception is that these dogs could be shown in Veterans, Stud Dog and Brood Bitch as Specials. Again, you must make your protest while your in the ring and before the judge examines and moves every dog in that class".

Q: What defines two normal testicles?
A: That is judge's call. Judge's will many times tell an exhibitor if he/she does not feel the testicles are normal

exhibitor if he/she does not feel the testicles are normal and to have it checked by a veterinarian. This is especially true in the Veteran's ring.

#### Change in Appearance by Artificial Means:

"The same holds true for this type of protest. You must make your protest while your in the ring and before the judge examines and moves every dog in that class. Again, we encourage you to protest before the judge starts going over the class".

**Q**: Is AKC placing more pressure on the judges to check for artificial substances?

A: We have always told judges to check for those. Your breed, chalk is used. A judge will pat a dog and see if a big cloud comes up. I have not seen that with Sammy exhibitors, but I have seen it in other breeds. A lot of times if the judge has 1 or 2 in a class with it, they will make an announcement to ringside "Any more dogs that comes into my ring with foreign substances, you're out!" So get it out, before you get in the ring.

Q: Is it true that AKC sends a letter, questioning why you had a foreign substance on your dog?
A: Yes that is true. You must write a response back.

**Q:** Then what's the action after AKC receives your response?

**A:** A committee decides if any retribution will held against you. You could be suspended, or be given a fine

#### **Double Handling:**

Q: Define double handling.

**A**: Double handling is when someone outside the ring, is determining the animation of dog in the ring. If you are exhibitor in the ring and you think someone is double handling, bring it the judge's or steward's attention. Same rule applies, you must be in the ring.

Q: Is it just animation? I had a daughter in junior handling, and I was dying to tell her to restack that rear!
A: No, that is still the same thing. You're interfering with her performance in the ring and actually showing a favoritism toward her and not the other children.

**Q**: If you're a steward, and exhibitor brings it to your attention, do you immediately let the judge know? **A**: Wait until the judge has a free minute, in between moving or examining dogs.

Q: If you are a steward and you see it happen, but no one has protested it, what do you do?
A: You may bring it the judge's attention.

Q: If I'm a exhibitor in the ring and I run out of bait. May I have someone outside bring me more bait?
A: That's fine. Water, bait, is OK. Because that person is not involved in showing that dog.

#### Viciousness in the Ring:

That is something that you can't protest, but you can bring it to the judge's attention. If there is a dog in the ring, a the dog is jumping on your dog, and the owner does not have control of their dog, bring it to the judge's attention. If it happens outside the ring, and the dog attacks your dog, or attacks you, you have to bring it up with the show committee. You have to write out a statement. They will have a hearing. They will determine if this person was neglectful in controlling their dog at the show. If the determine they were neglectful, the show committee can suspend them from all AKC privileges. That means they can't show, or breed, until the AKC Board determines what their punishment will be. This is a rule the Board put in effect this year.

#### Lameness:

You can not protest lameness. That determination is made by the judge only.

#### Topic: People Missing their Classes.

"You as an exhibitor are responsible for making you classes in time. As listed in any premium list, the show committee, ring stewards or superintendents are not responsible for you to be in a class. Many times what happens you are talking to your friends and you miss the class. Also, make sure you know what class you are entered in, and what when you should in the ring. That also counts for competing for reserve, winner's class, breed and groups. Once the judge has marked his book, that class can not be rejudged. The only exception is if the judge had started before the regular judging schedule. They have to go back and rejudge that class. The judging schedule is determined by the judge's watch. If you are standing ringside and the judge has not marked his book and you know you are suppose to be in the ring, tell the steward. The steward will then ask the judge if they will let the late arrival in. That is the judge's determination. Most judges are very good about that."

Q: Say there are 5 breeds scheduled for 10:15. Is a judge allowed to take them in any order? For example, the breed before ours had only 2 entries in the breed. The judge, judged them after our breed.

A: We will let that happen, if the same person owned both dogs. If the dog was owned by separate people, we would not allow that. That can be true for a single entry class. For instance, the bred-by class with one entry, if needed, could be judged after the open class. It is the judge's call.

**Q:** Can you ask the judge to start earlier than the schedule time?

**A:** No. If they do, then they are in violation. That would be reported to the AKC Office, and that judge would get in trouble.

#### Miscellaneous Q & A:

**Q:** What do you do about a judge that goes over part of the class and not the rest?

**A:** Bring that to the judge's or steward's attention. It's very easy, like in your breed, all white dogs, it can happen. They're human.

**Q:** Is it true for a National Specialty? We had a judge who made placements after only going over half the class. She appeared frustrated and confused. **A:** You should still bring it the judge's attention. As long as they have not marked their judge's book.

Q: What if they still do not go over your dog?
A: Then you come to me and I will talk to them.

Q: Can the AKC make a judge retire?

A: Yes they can. It's based on complaint letters sent to the AKC Judge's Department. 80% of my (AKC Rep) time is spent observing and helping judges. I will get a letter from the Office to watch so and so judge because they have certain problems. I will speak to a judge prior to them judging that day, and tell them "I had a letter from the Office, stating you had some problems. We don't want to see them today". I'm telling you, I don't see them.

**Q:** What if you are an exhibitor or a steward and you notice alcohol on a judge's breath?

**A:** It has happened. The AKC has really come down hard on alcohol and drug abuse. If you as a steward notice your judge is impaired in any way, let the AKC rep know about it. If they are, a letter will go to the Office. We do not allow alcohol until after judging, including groups. We do not want a judge to get intoxicated and we want them to act professionally.

**Q:** Is there more pressure on clubs now? I heard about a club that was disciplined for not calling a bench committee.

**A:** If there is a written protest by the exhibitor, your club must investigate it. It is your club's determination if there needs to be a hearing or not. If you don't then your club is in violation of AKC rules. If your club is not abiding by our rules, then should we not allow you to have dog shows. We have the right to take away your privilege of holding shows. They have done it.

**Q:** Discuss the problem about an exhibitor who double enters a dog.

A: This does happen, particularly with novices. If you double enter a dog, say it's entered in the puppy class and open class, once you start to compete, you have to continue to compete. If you enter the puppy class and lose, and show in the open class and win, you can not come back into the winner's ring, because you are a defeated dog.

**Q:** How many times is that dog counted for point's calculation?

**A:** The dog is counted once.

**Q:** What happens as a club, and we receive entries like that. What action do we take?

**A:** Your show secretary, will have that noted in italics in the judges book so that they are aware. The judge does not make determinations on eligibility. If the (Continued on page 9)

situation occurs, where the dog loses one class, and wins the other class, the judge is suppose to say you can not back in for winners, because you have been defeated. If the dog wins both classes, they may go into the winner's class and be eligible to win the Winners class.

**Q:** We offer a Sled Dog and Bitch class in addition to the regular Breed class. If you enter both, do you have to show in the Sled class?

**A:** You do not have to show in the Sled class, you may forfeit that entry and continue to compete in the Breed class. If you do compete in the Sled class and lose, you can not compete in the Best of Breed class.

 $\mathbf{Q} \colon \mathsf{Once} \ \mathsf{a} \ \mathsf{dog} \ \mathsf{has} \ \mathsf{been} \ \mathsf{registered} \ \mathsf{with} \ \mathsf{AKC}, \ \mathsf{can} \ \mathsf{it's} \ \mathsf{name} \ \mathsf{ever} \ \mathsf{be} \ \mathsf{changed}?$ 

A: Never.

**Q:** What situations can you change an entry after the entry closes?

A: In the Puppy class, where they are broken down to 6<9, 9<12 and you are entered in the wrong class, you may go to the superintendent and change the entry and they will change it in the judge's book. You must do this before any judging starts in that breed. If you send in an entry and the sex is wrong, they can also change that, even if it's your mistake. You can also move up a dog to Best of Breed, but they must be done 30 minutes before any judging. If you are on a 3-day circuit and your dog finishes the first day, you may move them up to the Best of Breed class, that same day.

**Q:** Can you enter a champion in non-Best of Breed class, such as Open?

**A**: Yes. It happens a lot in rarer breeds, when they need to build a major. However, it backfires a lot. The judge will find that champion and put them up.

**Q**: If a judge withholds a ribbon, how does that affect the point's calculation?

A: If the judge excuses the dog, it does not count. Judges may excuse for lack of merit and they write that in the judge's book. The Office requires that information. If the judge awards ribbons, even if he/she withholds the first place ribbon and gives it the second place ribbon, the dog counts.

**Q:** If a judge incorrectly marks their judge's book, what should the steward do?

**A:** The steward should bring it to their judge's attention. We also encourage exhibitors to always check those judge's sheets. If it is incorrect, notify the judge immediately. Otherwise, you must prove it by sending ribbons and pictures into AKC.

**Q:** If there is a judge change, up to what point can you get your money back?

**A:** Before any judging starts of that breed, then you have the write to go to the show secretary or superintendent, and ask for your money back.

**Q:** Can you get your money back if there is a change in the location of the ring, going from an outside location to an inside location and vice versa?

A: Yes, as long as it's listed in the premium list that

your breed is to judged outside or vice versa, you can request your money back, because they have changed the environment your dog will be shown in.

**Q:** Will AKC encourage large breed clubs to pool their resources and get a quality show site that everybody could share?

A: A committee headed by Pat Scully has been formed to look into this. If you have any recommendations, send it to her. Her address can be found in the AKC Judge's Book. We encourage quality show sites, but the ruling is right now is that club can not have back to back shows out of their area. They can hold one show out of their area, but the other show must be within the city their club is associated with. When a club applies to the AKC for approval, they have a geographical location, and they want to make sure they service that area. The result sometimes is a show in a less quality facility. In the east coast, they can travel 350 miles and hit many area dog shows. Traveling 350 miles in Colorado, doesn't even get you out of the state. I encouraged people who work for the Office to come out and see our situation. Recently, AKC Vice President came to shows in Longmont in June. His secretary housed him at the Marriott on Hampden and I-25. He had to drive 60 miles each day to get to the show. He couldn't believe it!

**Q:** What do you do when you see unentered dogs at a show site?

**A:** Tell the show chairman. Particularly puppies, they are being exposed to all sorts of germs, such as parvovirus.

**Q:** When should a steward call for a show photographer?

**A:** The stewards before judging begins, should ask the judge, when they want to take pictures. A judge should not hold up their judging for a photographer. If the judge does hold up a ring, talk to the AKC Rep.

We have a lot of good judges. Every time they enter a ring, they put their reputation on the line. If you have been in dogs a long time, you have a lot of friends. Just because you put up that friend is not necessarily you favoring that friend, but because they brought you the right dog that day. A lot of people complain about handlers winning a lot. I was a breeder - owner, and I did a lot winning. Let me tell you why. I didn't show my dogs until they were ready to be shown. I conditioned them, I socialized them, and they were ready to be shown. It's fun to show puppies. Worse is showing an unconditioned, or not in good coat dog and you end up wasting your money on 3<sup>rd</sup> and 4<sup>th</sup> place. Take those dogs to matches and training classes. Wait until they look there best. I finished a lot of dogs in 6 shows, because I took them out when they were ready, not because the judge knew me. My breed is Whippets.

Q: There was a situation where Judge A exhibited to Judge B and won. Then they swapped and Judge B won under Judge A. What do you do in that situation? A: Judges know if they are involved in situations that are not quite kosher, they won't get anymore breeds. Most judges want to get additional breeds. The next time that judge is judging, you as exhibitors do not need to exhibit under them. Clubs can not afford to hired

judges that don't draw entries. It's that simple.

**Q:** We had a dog entered in junior showmanship and conformation. Because there were time conflicts we always had to decide if that day we would compete in juniors or conformation? In juniors, what difference does it make which dog they take in? Can we substitute a dog we owned, for the junior's competition?

**A:** You can now substitute a dog, as long as you own that dog, up until 30 minutes prior to judging juniors. This has been in effect for the last 1 or 2 years.

"I make myself very visible at dog shows. I represent the AKC. Your concerns are my concerns and the AKC's concerns. If you have a problem at a dog show, please come to me and I will try to rectify it. Also, if you experience a judge, who has done a good job of judging, let them know. They hear a lot of negatives. These judges really try to do a good job. If they make a mistake, it's usually because of lack of knowledge, not shenanigans. Thank you and I hope to be back next year." - Alan Odum, AKC Representative
